

Annual Meeting  
March 19, 2019

LWV President, Teresa Briggs, introduced Carrie Lancaster, Advocacy Chair from the State League, and Sharon Ailslieger, also from the State League, and her husband.

Carrie talked about her new position, “Advocacy”, how we could advocate from home, and how to access information from the internet (LWVK), listen to audios (youtube), from the legislature, find the calendars to see what is being discussed, how your legislator voted, listen to other sessions, check positions, and more!

An “old-fashioned” business letter gets more attention! Carrie discussed “tips for visits to your legislator.” Always groups of 2 or 3, make an appointment, be cordial to the legislator, thank them for their time. We can contact Carrie anytime –she left her business cards, and she believes that it is important for us to let them hear from us.

Rita Burns spoke on the 2018 Legislative Observers as well as “transparency.” Carrie and Rita began as observers in 2018. Why do we go as observers? –to be informed and know what is going on. The “corps” listen to committee meetings and are “seen” being there as observers. They did get training, introduced to the website, [www.kslegislature.org](http://www.kslegislature.org), observed, and found out that hardly anyone meets on Fridays. They have meetings with experienced observers, and find out how things work, write reports, (lots of information on the website. She talked about a committee and went to a meeting about a bill—and never heard about it again. Lesson#1: The Power of Committee Chairs. They are appointed by the chair of the party—very loyal members of that committee. Susan Wagle appointed herself, chose 2 “newbies”, dismissed 2 who were on the committee, and passed SB22. It’s up to the committee chair to decide which bill to discuss. It doesn’t even get considered unless the “chair” chooses it –not a “democratic” process, rather a “controlled” process. There can be NO recording or photographing unless the committee assistant agrees, but some committees never have minutes. Even if it is heard, you may not hear the outcome. Anyone can submit a bill.

Legislators are allowed to “gut” the contents of a bill that has passed either the House or the Senate, insert different content, even unrelated topics and with little discussion, “go.”

There were 19 bills in 2018 that were trying to make the bills more transparent, putting names on bills, recording, etc. NONE passed. Most did not make it to the table.

From Observers to Advocates for Transparency—they drafted a statement that passed by the State LWV—to allow the record, etc., and it passed. (See statement on Legislative Transparency, June 2, 2018.) Gives them a “to do” list. Last year there were 19 “transparency” bills; this year there were only 2.

It’s our job—we are the LWV!

Teresa introduced Sharon, our Intra-League Coordinator.

Sharon gave a presentation for LWVE –gave the Emporia League a \$500 check for Terry Erisman. Sharon has been to all the Leagues, except for 2, and says the main complaint she hears is “communication.” Sharon says it is important that all Leagues “are on the same page.” We’re a 3-tired organization: Local, State, and National.

Teresa add “Convention” under “Centennial. Betty (Margaret) moved to accept the agenda. Motion carried.

Teresa reviewed the Annual meeting booklet. The Treasurer’s report is separate. Ann added that Judy Wild is helping with recording the dues payments. Jerry Fair has checked the books and they are fine. Other reports are in the booklet. Bob Grover has been very helpful with meetings as well as Doug McGaw working on the website. Mary added that we need to be move visible with the “gun issue” and “Moms Demand Action.” Mary, Doug, and Bob went to Topeka about this. Julie reminded us that there is a “Legislative Dialogue” this Saturday at the Presbyterian Manor at 8:00 for refreshments, and the Dialogue at 8:30. Ruthann (Eleanor) moved to accept and approve the changes in the booklet.

Ann talked about the budget and the treasurer’s report and the member contributions. This year we “beat the budget” (see Financial Report) –a new line item in the LWV Ed. Fund: We received a \$500 grant from the

State Ed. Fund. See pgs. 7 & 8—income from the memorial for Georgia Taylor.

Julie (Doug) moved the approval of the treasurer's report. Motion carried.

Discussion on the dues schedule to encourage young students to join; we will not charge them dues until 2022. Bob, Ruthann, and Teresa are working on a grant to fund registering these young voters, especially in underserved populations, at ESU, and also, a method of contacting them before the next election to remind them to vote# We need to waive the \$20 fee until 2022,

Discussion about the "women's right to vote," as well as discussion about DEI. Bob, Ruthann, and Teresa are already working on the first three.

Centennial Celebration – planning events to celebrate the Centennial. We need to be visible to the community, and to work with Lisa at the History Center.

Discussed the 501c4 converting to 501c3, and the changes that we may consider. The conversion may not concern us, but this will be brought up at the convention.

Teresa talked about the "Bookmarks" and talked about going to the Convention at Manhattan.

We do have the Council next year at Emporia!

We enjoy good rapport and support from our County Clerk Tammy Vopat who is also actively involved in voter registrations as well.




